

### First things first

#### **Register to vote:**

- Go to: vote411.org/pflag
  - Check your registration status
  - If you are not registered REGISTER NOW.
  - Find information about who is eligible to vote in Indiana
- When you register you will be asked for your current address and ID Number (driver's license, state ID, or social security number).
- The voter registration deadline in Hawaii is **October 7.**





### First things first

**Register to vote.** 

- Indiana residents can check their registration status at <u>vote.org</u>.
- If you are not registered REGISTER NOW. You can register at: indianavoters.in.gov/.
- You can find information about who is eligible to vote in Indiana here: <u>vote.org/voter-registration-rules</u>.
- When you register you will be asked for your current address and ID Number (driver's license, state ID, or social security number).
- The voter registration deadline in Indiana is October 7.





### **Voter Identification**

In Indiana, photo IDs are required to register and cast a ballot.

- Your photo ID must meet specific criteria to be considered acceptable. If you do no present an acceptable ID, you can cast a provisional ballot. You have until noon 10 days after the election to provide the necessary documentation or affirm you have an exemption.

## **Voting While Trans/Nonbinary**

The state of Indiana does not provide any specific guidance for trans and nonbinary voters. Here are a few recommendations from Advocates for Trans Equality:

- Bring valid ID and backups (voter registration card, utility bill)
- Share the #VotingWhileTrans guide with poll workers
- If needed, connect with a volunteer attorney on-site or call the National Election Protection Hotline (866-OUR-VOTE)
- Worst case, request and cast a provisional ballot and be sure to ask for follow-up instructions

## **Voting While Living With a Disability**

- All polling locations will have at least one accessible voting machine and all sites must have a physically accessible facility.
- Curbside voting is **not** available.
- Voters with disabilities can receive assistance voting. You may bring someone or request help from an election work. The person assisting you cannot be your employer or a representative from your union.

### Absentee voting or voting by mail

#### Indiana requires an excuse for absentee voting. Valid excuses include:

- You will be absent from the county on Election Day.
- You have a disability, are at least 65, and/or are confined due to illness or injury.
- You're scheduled to work during the entire 12 hours that the polls are open.
- You are prevented from voting because of a religious discipline.
- You are a participant in the state's address confidentiality program.
- You are prevented from voting due to the unavailability of transportation to the polls.





### Absentee voting or voting by mail

#### Vote by mail.

- To vote absentee by mail, a voter must complete an <u>ABS-Mail</u> (<u>En Espanol</u>) application before each election. It is available online, it can be mailed by request, or completed in person.
- The ABS-Mail application must include a photocopy of their ID or a voter ID Number
- Voters must return their ABS-Mail application by 11:59 pm on October 24 (12 days before the election). The application must be received by that date and time.
- In Indiana an absentee ballot must be received by 6 pm on Tuesday, November 5.





**PFLAG recommends that voters** request their absentee ballots as soon as possible and get them in the mailbox no later than Tuesday, October 22.

## Early voting (In-Person Absentee)

#### Vote early.

- All registered voters in Indiana can vote early (in-person absentee) for any reason.

- In-person absentee voting begins in Indiana on October 8 and ends on November 4 at 12pm.
- Voters who plan to vote in-person absentee in Indiana are required to have identification. Learn more here: <u>in.gov/sos/elections/voter-information/photo-id-law/</u>





### **Voting on Election Day:**

#### Vote on election day.

- Polls open in Indiana at 6am and close at 6pm on Tuesday, November 5.
- You can find information about the location of your polling place here: vote411.org/pflag
- If you arrive and are told you won't be allowed to vote:
  - Don't panic. Ask why, fix any problems, ask about same day registration, request a provisional ballot, etc.
  - Call 866-OUR-VOTE or 888-VE-Y-VOTA.
